WIDE+ IS SEEKING NEW MEMBERS: APPLY BY 20 JANUARY

WIDE+ is seeking new member organisations and individual members to strengthen our feminist network and amplify our collective impact. Applications are open until **20 January**. The process is simple and membership fees can be waived for the coming years.

Why join WIDE+?

For ten years, WIDE+ has connected feminists across Europe, but we haven't engaged in an active membership campaign like this before. Many people and organisations may not be aware they can join the network. By joining, **new members can help the network amplify feminist perspectives, bring in new experiences, and further collaboration and solidarity.**

A membership at WIDE+ means **being part of decisions on the course of the network with other members, joining our collaborative spaces like working groups and sharing your news through our newsletter and social media.**




For further information or for any questions, kindly contact our general coordinator Gea (info@wide-network.org) who is happy to answer any questions.

If you do not know any members to list as recommendation members in your application, you can list Gea Meijers as the recommendation member, and she will follow up on this with you. Each application is reviewed by the General Assembly of WIDE+'s members, who will make a final decision.

Waiving the membership fees

A WIDE+ membership is about sharing common goals for changing our societies and Europe at large. The annual fee for a member organisation ranges from 100 to 500 Euros and from 25 to 100 Euros for individual members. This fee can be waived by the board or replaced with your volunteer contributions, such as project support for example. Don't let finances hold you back—we can find a way for you to join.



WIDE+ mission




WIDE+ promotes a **feminist socio-economic and political vision** rooted in **rights, equality, and social justice**. We advocate for a socio-economic model that values **care and well-being** over production growth, a world in which people live within planetary boundaries and where political participation is possible for each person in democratic societies. Our political model is built on **democracy, transparency and inclusion**.

About WIDE+

WIDE+ is a European network of feminist activists, scholars, and women's rights organisations reaching over 300 associations, through its national member networks and organisations across Europe. WIDE+ promotes human rights by analyzing the systemic causes of gender inequality and advocating for transformative change.



WIDE+ finds its roots in 40 years of collaboration between feminists in the global South, the Majority World, and feminist economists. In the last 10 years, WIDE+ has bridged this global expertise with feminist activism in Europe.



Our current work

Currently, we are engaged in projects that work on **fostering migrant women's rights in Europe, and feminist economic issues including addressing intersectional discrimination in online hiring processes, gender and climate justice, and promoting popular feminist economic education**. We offer transnational exchanges on the **backlash from ultra-conservative movements** in particular on women's and LGBTQI* rights and democratic rights. Our external focus is on **promoting narratives of peace and feminism in foreign policies**, in particular in trade policy.

Why now?

The direct cause for organising this call and General Assembly stems from the Board's decision to apply for an EU call for proposals for the 3-year framework partnership agreements to support European networks, civil society organisations active at the EU level and European think tanks in the areas of Union values (CERV-2025-OG-FPA). To qualify, we need to ensure that our current partner organisations become member organisations and we need a couple of new applicants from new EU-member countries. The call closes on 28 January.

We need member organisations in at least 14 of the EU member states for this call. Currently, we lack members in Croatia, Republic of Cyprus, Czech Republic, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, Poland, Portugal, Romania, Slovakia, and Slovenia. Organisations based in one of the countries stated above are encouraged to apply.

However, we are also seeking and inviting member organisations and individuals from **all over Europe, not only within the EU**. We are a European network in which **EU boundaries are not our boundaries**.
