Launch of new Gender and Climate Justice E-learning Tool



We are excited to announce the launch of the **“Gender and Climate Justice” e-learning tool**, which has been developed as part of the project entitled **“Gender and Climate Justice: Knowledge for Empowerment” or COPGendered for short.**

The e-learning tool is a **free interactive course** for everyone that want to quickly get an understanding of the complex interconnections between gender and climate justice, featuring engaging videos, inputs, and exercises. Key topics include **climate, gender, LGBTIQ+, mobility, energy, and extractivism**, with examples from both the Global South and Global North.

In July 2024, WIDE+ organised a panel at the IAFFE (International Association of Feminist Economics) conference in Rome under the following title: **Trade policies in the context of macro-economic policy making: feminist reflections on resistance and alternatives.**

Panel presented included the following WIDE+ members: Edm  Dominguez, Gea Meijers, Mirela Arqimandriti, Patricia Munoz Cabrera and Christa Wichterich.

The speakers looked at the lack of gender equality and human rights considerations in EU trade policy within broader macroeconomic contexts, highlighting contradictions in key policy areas. It also explored feminist alternatives and resistance and strategies for the future rooted in intersectional, decolonial, and transformative feminism.

COPGendered Event in Spain by Mundubat on 20 February


As a part of the **COPGendered Erasmus+ Project**, Mundubat organised an event in San Sebastian, Spain, on 20 February. The event aimed to discuss and explore the **negative effects of climate change on women's lives**.

Climate justice requires a transformation of the current economic and political system.

Mundubat is committed to this strategic, comprehensive and transformative option, which seeks to address the inequalities and injustices caused by climate change from a perspective of equity, solidarity and respect for human rights, as well as a commitment to present and future generations.

Nancy Contreras from GADIP introduced the COPGendered project and the work of WIDE+ at the event. And experiences of women and women's and feminist organisations working in this field were exchanged.

Silke Steinhilber's analysis of the 30th review of Beijing Platform for Action by countries in Europe and Central Asia
