What they're looking for:

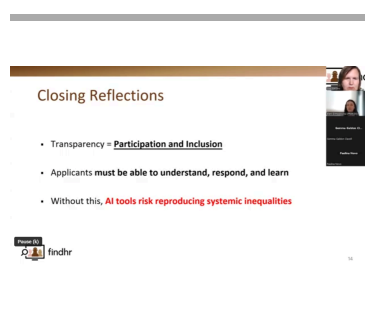
- E-learning modules, online games, educational videos, social media content (Instagram, YouTube, etc.) with a feminist perspective

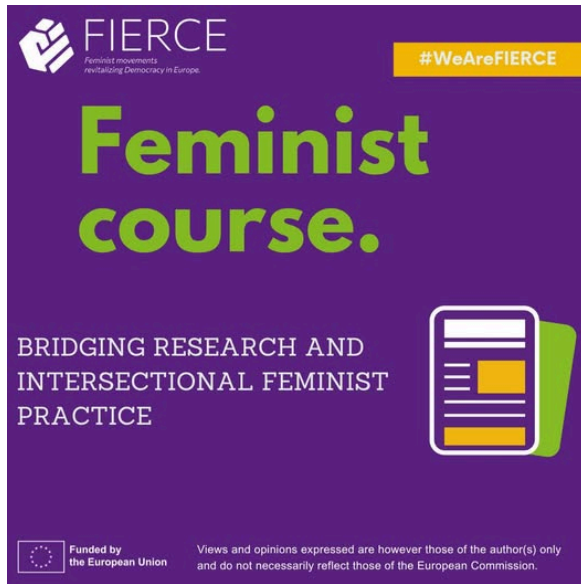
**New FIERCE podcast episode available on Greece**

## Women in Migration Network: Summary Report from the Feminist Forum on Migration and Displacement



In December 2024, WIMN and feminist partners organised the **Feminist Forum on Migration and Displacement (FFMD)** in Bangkok, Thailand.

With over 100 participants, the forum explored the unique **challenges faced by migrant and displaced women and gender-diverse people**, developed strategies for advancing their rights, and contributed to shaping a bottom-up, intersectional feminist migration policy.
